INDEMNITY & DAMAGES

I, the undersigned, understand and fully accept:

1 That I, and those persons accompanying me, are well-acquainted with and fully aware of and appreciate the real dangers and risks that are associated with tented camps arising from the presence of wild and dangerous animals, reptiles, birds and insects, inclement weather and other risks mentioned below.

2 That the owners of Eagles Eyrie, ie John Comley, is fully indemnified against:

(i) Any bodily harm, injury, death and/or loss to property which may arise as result of any encounter with and/or the presence of wild animals and/or reptiles and/or birds whilst on the premises or property of John Comley including Eagles Eyrie.

(ii) Any bodily harm, injury, death and/or loss to property which may arise as result of:

(a) any fire due to any cause whatsoever

(b) any act of weather, including lightning, wind, rain, hail, and

(c) any act of God whilst on the premises or property of John Comley including Eagles Eyrie

(iii) Any bodily harm, injury, death and/or loss to property which may arise as result of any accident of any kind whilst on the premises or property of John Comley including Eagles Eyrie

(iv) Any bodily harm, injury, death and/or loss to property which may arise as result of an encounter with and/or the presence of any intruders or third parties whilst on the premises or property of John Comley including Eagles Eyrie.

(v) Any bodily harm, injury, death and/or loss to property and/or inconvenience which may arise as result of power outages or failures and/or electrical faults and/or gas-related incidents whilst on the premises or property of John Comley including Eagles Eyrie.

3 I agree that if I enter the adjoining reserve I do so entirely at my own risk, knowing that wild animals present a danger. I will in no way whatsoever hold the owners of Eagles Eyrie responsible for any harm or injury that may occur to me or my companions on the adjoining reserve.

4 I agree to waive all claim or claims of whatsoever cause or nature howsoever arising against the owners of Eagles Eyrie, their associates, servants, employees and/or any person connected whether directly or indirectly with the running of the camp and fellow guests or invitees which they may have arising out of any harm, injury, death or loss suffered whilst on Eagles Eyrie, and whether arising from an act of commission or omission on the part of those hereby indemnified or anyone of them.

5 I indemnify and hold harmless and free, the owners of Eagles Eyrie, their associates, servants and employees and/or any person connected, whether directly or indirectly, with the running of the camp and fellow guest or invitees from any and all claims of whatsoever cause or nature which may arise on behalf of their spouse, partner, children, whether minor or adult, or relatives and/or those persons accompanying them to the property whether as an invitee and who may suffer injury or loss whilst on the premises or property of the lodge and whether arising from an act of commission or omission on the part of those hereby indemnified or anyone of them.

6 I agree to pay for all damages and/or losses that may result from intentional and/or unintentional acts or as a result of acts of negligence.
